The international seminar of the Deutscher Frauenring e.V (DFR) 2013 is dedicated to the changing international Law and the efforts for to include gender into the international peace and security architecture. Women act increasingly as actors and are defined as legal subjects of the law and should be at all levels represented as such. Men and women are required to question their roles and social stereotypes on the basis of gender competence. All stakeholders are responsible on the one hand for acting in a gender equal way and on the other to enhance peace and human security. First experiences show that often the implementation, despite international legally binding frameworks, is far from sufficiently ensuring women's participation, access to the legal system and justice or perspectives in reconciliation processes and in rebuilding new societies. "Gender" remains a missing link, which should be strengthened. Gender-inclusive and -aware perspectives are needed and demand that dual constructions femininity and masculinity are challenged and new conceptualized in the respective regional context, so that they comply with human rights and that they will have a sustainable impact for-peace.

This seminar organized in cooperation with the Gunda-Werner Institute within the Heinrich-Boell Foundation (GWI) and the European Academy Berlin (EAB) aims at presenting several chosen legal and reconciliation processes, in order to bring the dialogue about the balance between reconciliation and justice in the legal sense a step further on the way. It intends to discuss how to develop and further support the right of recognition of war crimes and violation of human rights against women as well as recognition of gender-based violations. A few chosen examples will be presented in which women could take an empowered role and in which non-governmental organizations (NGOs) and civil society actively participate. The references of this discussion are instruments of international law like the UN Security Council Resolution 1325 on "Women, Peace and Security", UNSCR 1820 and following resolutions, CEDAW as well as the Beijing Platform for Action of the 4th UN- World Conference on Women. Activists and women's rights organizations have been for long committed to the development of these legal instruments, to the inclusion of women and strengthening their role as actors in peace processes and in obtaining a

gender inclusive and just human security architecture for all people irrespective of their gender identity and lastly committed to ending impunity for war crimes. The reality of justice and the political standards of political processes of participation change slowly. In some cases big efforts lead to good results. However, challenges of the past remain unsolved, that some societies don't account for and where the victims remain, despite of their efforts, disregarded: also in relation to these cases, the question arises how to find new ways to ensure justice, so that the requirements for peace can be ensured.

The cooperating partners intend to bring to light different international processes related to the recognition and compensation of victims, in order to highlight and strengthen the a gender inclusive implementation which is required by women and human rights standards. In the same time the DFR and its cooperating partners aim at bringing new perspectives for the unsettled legal and reconciliation processes. The DFR wishes to bring the debate further so that war crimes and violations of human rights against women and which are gender based can in the future be accounted for as "lesson learned".

The DFR and its partners GWI and EAB expect that legal and reconciliation processes can only be a useful requirement for national and international peace and human security if they are gender inclusive and sustainable, and thereby assign and recognize their related victims an active role, irrespective of their sex, gender or gender identity. Furthermore reconciliation and legal processes should be public and transparent. They need to be accessible awareness raising processes for the citizens and involved partners and finally must be well documented. Victims must seek for justice through access to legal processes and impunity should be counteracted.
